A tax rate of \$0.013218 per \$100 valuation has been proposed by the governing body of County Wide School.

The no-new-revenue tax rate is the tax rate for the 2021 tax year that will raise the same amount of property tax revenue for County Wide School from the same properties in both the 2020 tax year and the 2021 tax year.

The voter-approval rate is the highest tax rate that County Wide School may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that County Wide School is not proposing to increase property taxes for the 2021 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 2, 2021 AT 3:00 PM AT County Court Room, First Floor, Rusk County Courthouse, Henderson, Texas.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, County Wide School is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Directors of County Wide School at their offices or by attending the public meeting mentioned above.
