All defendants are ordered to appear in the CCL courtroom at the following dates and times. There will be **no agreed passes for cases filed more than six months prior to February, 2021.**

Motion Deadline for Trial Docket: January 5, 2021 at 5:00 p.m.

Pretrial Hearing & DOCKET CALL: January 6, 2021 at 8:30 a.m.

Jury Selection: February 22, at 8:30 a.m.

DEADLINE FOR PLEA AGREEMENTS will be February 19, 2021 at 9:00 a.m. Such agreements must be signed by defendant and returned to the District Attorney's Office by the date and must contain a waiver of jury trial.

It should be noted that although Article 33.04, V.A.C.C.P. allows the State to waive the presence of the Defendant, the States' Attorney has advised this Court that it does not intend to do so unless:

- (1) An agreed continuance, evidenced by a written motion, has been prepared and submitted to the County Attorney's Office.
- (2) Some other agreement has been reached with the County Attorney's Office as to an announcement to be entered on the Court's Docket.

Further, pursuant to Article 28.01, Section 1, V.A.C.C.P., all preliminary matters must be raised at the time of the pretrial hearing or will not thereafter be allowed to be raised.

All Attorneys and Defendants must be present at the Docket Call unless a written announcement of "Ready" has been filed prior to Docket call, signed by the defendant and setting out the date's of jury selection. This policy will be **strictly** enforced, and failure to appear at the calling of this docket or reaching an agreement in advance with the County Attorney's Office will be subject to the forfeiture of the Defendant's bond issuance of a capias for the **arrest** of the Defendant.

Due to COVID-19, Docket Call is now being held at a new location, the Rusk County Expo Center. All Defendants will be required to wear masks and social distance while in the Expo Center. Masks will be provided to anyone who does not have his or her own mask.
