**Bench Trial Docket Call: February 1<sup>st</sup>, 2022 at 9:00 am.**

All Pretrial Motions/Plea Hearings must be accompanied by an Order Setting Hearing on Pretrial Motions/Plea Hearings. You are required to set the hearing in advance of the Docket Call date by agreement with the District Attorney's Office. Follow my general instructions for setting hearings on my website [co.rusk.tx.us](http://co.rusk.tx.us). If you set a plea hearing you must do so with Judge Hale's office per instructions on plea agreement.

Failure to appear to Docket Call or any other setting as ORDERED will result in the forfeiture of bond and issuance of an Arrest (CAPIAS) Warrant for the arrest of the Defendant, and upon arrest, setting of a cash bond to be released from jail.

Unless you have plead and obtained a filed Judgment or Pretrial Diversion Agreement with the Clerk or your case has an Order of Dismissal or Order setting Hearing filed with the Clerk, the attorney and defendant's attendance is required. At the docket call, Trials will be scheduled by the Court at the Courts discretion during the month of February, 2022.
