Notice is hereby given that the polling places listed below will be open from 7:00 A.M. to 7:00 P.M., on November 3, 2020, for voting in a Joint General Election to elect Presidential Electors, Members of Congress, Members of the Legislature, state, district, and county offices as required by Article XVI, Section 65 of the Texas Constitution.

- Leveretts Chapel ISD – to elect three At-Large School Board Members, vote for none, one, two, or three
- Rusk ISD – to elect two At-Large Trustees, Three Year Term and one At-Large Trustee, Two Year Unexpired Term
- Countywide School Board – to elect one At-Large Trustee and one Trustee Precinct 1
